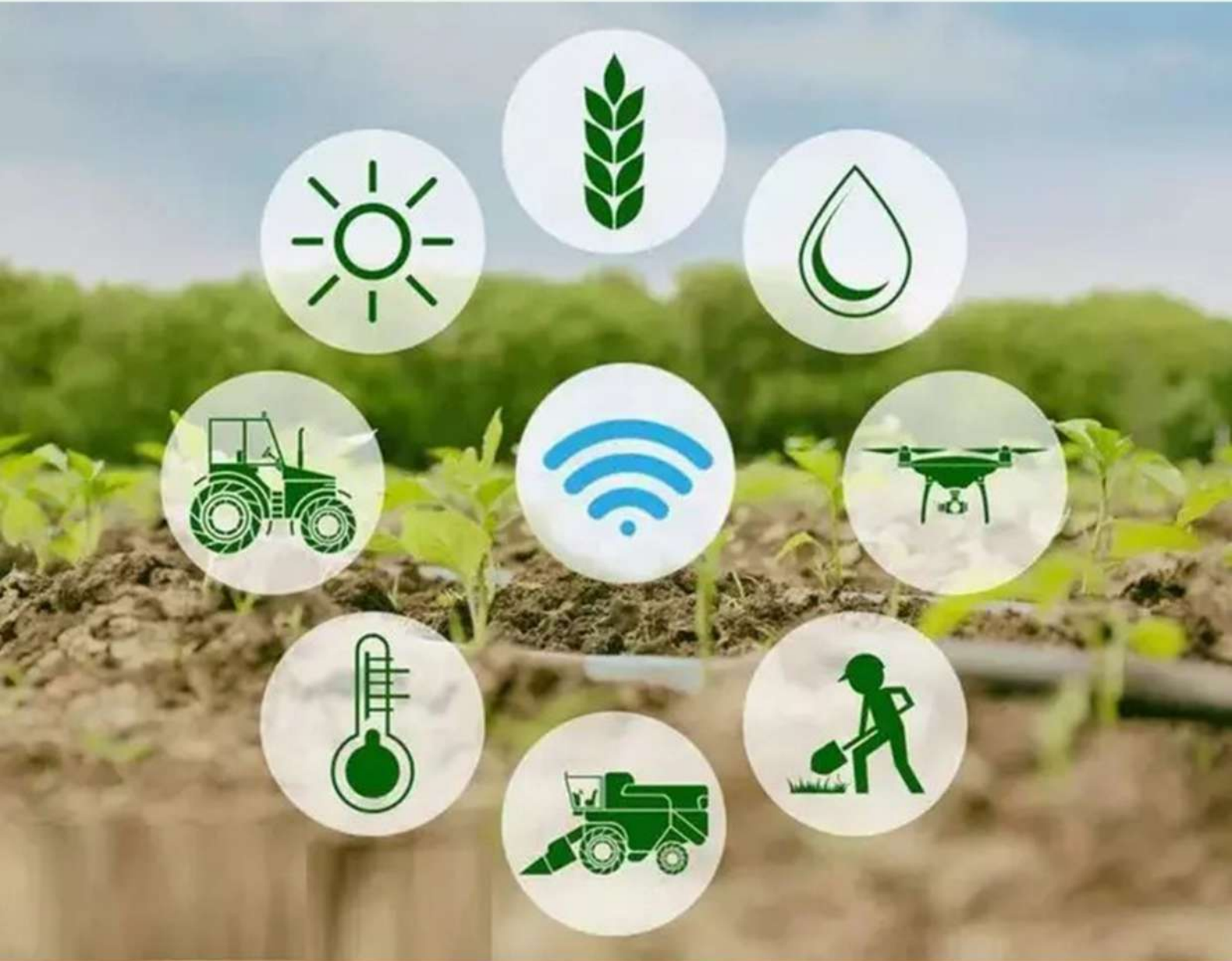

## **Exhibitor Rules and Regulations**

### **Prohibited Items**

The display of: arms, ammunition, explosives, radioactive materials, flammable and inflammable items, poisons, illegal drugs, alcoholic drinks and foodstuffs deemed not in keeping with the character and purpose of the event is strictly prohibited.

### **Safety and Security**

- a) The organizer shall undertake, with the care of a competent manager, the protection and maintenance of the exhibition hall, as a whole.
- b) The security of exhibits and related materials is the responsibility of each exhibitor, insurance coverage is at their discretion.
- c) Exhibitors are responsible for arranging and covering all costs related to transportation, set-up and tear-down of their exhibit and related materials in the timelines outlined in the general information section.

### **Consignment**

Exhibition cargo should not be consigned to the Addis Chamber International Exhibition or the Addis Ababa Chamber of Commerce and Sectoral Associations.

### **Exemption Clause**

Should the organizer decide to change the duration or dates of the event, or cancel it due to natural calamity or other force majeure, the Organizer shall refund in full the registration fee and any booth fees already submitted by the exhibitor.

### **Regulations and Compliance**

- a) The Organizer reserves the right to change event participation regulations; however, any changes must be communicated to the exhibitors within a reasonable timeframe.
- b) The Organizer will provide to exhibitors, general information, subsidiary regulations and any other documents needed to carry out the event's operations.
- c) The Exhibitor as well as other concerned parties must observe these rules and regulations and details noted above.

### **Settlement of Disputes**

Any disputes or questions, which may arise at any time hereafter, between the Organizer and the Exhibitor, regarding the contents of these exhibitor rules and regulations, or the rights and liabilities of the parties hereto, shall be finally settled by ad-hoc arbitration. The arbitration shall take place in Addis Ababa in accordance with Ethiopian law. The decision of the arbitral tribunal shall be final and binding upon both parties.
